GRANT AGREEMENT

This grant agreement (this "Agreement") is made effective on [12/01/2020], (the "Effective Date") between **Johns Hopkins University** (the "University"), a Maryland nonprofit corporation, and the **Charles Koch Foundation**, a Kansas nonprofit corporation (the "Donor"). This Agreement is for the benefit of the Program on Educational Pluralism (the "Program"), which is housed at the Institute for Education Policy ("Institute") in the School of Education (the "School") at the University. The University and the Donor are sometimes referred to in this Agreement individually as a "Party" and collectively as the "Parties." The Parties agree as follows:

1. <u>Promoting Academic Freedom.</u> Consistent with the Donor's principles of supporting open inquiry and a diversity of ideas in higher education, the Donor's grant is intended to help promote a republic of science at the University where ideas can be exchanged freely and useful knowledge will benefit the well-being of individuals and society. Thus, the Parties agree that the academic freedom of the University, the Program, and their faculty, students, and staff is critical to the success of the Program's research, scholarship, teaching, and service.

2. <u>The University's Proposal.</u> The Parties enter into this Agreement based on the University's proposal, which is hereby incorporated into and made part of this Agreement, and attached as Attachment A (the "Proposal"). The Proposal reflects the vision of and relies on the leadership of Ashley Berner, who was selected by the University, according to its normal procedures, to be the director of the Program (the "Program Deputy Director"). As stated in the Proposal and consistent with the Program Deputy Director's vision, the mission of the Program is to provide intellectual leadership and explore policy alternatives with educational leaders looking to advance a system of diverse, publicly funded, and publicly accountable district, charter, and private schools (the "Program's Mission").

3. <u>The Program Activities.</u>

a. <u>Generally.</u> To support the Program's Mission, the University desires to create the following positions and activities to affiliate with the Program, collectively referred to as the "Program Activities." The Program Activities are described more fully in the Proposal and include a "Deputy Director," "Institute Director," "Administrative Coordinator," "Institute's Financial Administrator," "Director of Research," "Pluralism Research Analyst," "School Culture Program Manager," "Two PhD Students," "Pluralism Research," "Media Outreach," "Team Travel" and "PhD Student Research/Travel Funds." The University shall use any funds received under this Agreement to support the Program Activities in accordance with the terms of this Agreement. According to the University's normal procedures, the Program Deputy Director is responsible for directing the Program Activities, which includes allocating and administering the Program's budget, supervising Program staff, mentorship, and other duties to advance the Program's Mission as deemed appropriate by the Program Deputy Director.

b. <u>Selection According to the University's Normal Procedures.</u> The Parties mutually agree that the selection of the foregoing positions and fellowships by the University will follow the University's normal procedures for selecting such positions and fellows for the applicable academic units. As a matter of academic freedom for academic units at the University, individuals who hold positions with or are affiliated with the Program must be approved by the Program Deputy Director, in accordance with College's and University's normal procedures.

4. <u>The University's Support for the Program</u>. The University shall support the Program Programs to advance the University's mission. As part of this support, the University shall ensure that the faculty, students, and staff working with the Program have adequate space to achieve the Program's Mission. Therefore, the University shall provide the Program with sufficient contiguous office space including shared conference and meeting spaces.

5. <u>The Donor's Support for the Program Activities.</u>

a. <u>Contributed Amount.</u> Subject to the terms of this Agreement, the Donor will contribute funds to the University solely to support the Program Activities to advance the Program's Mission (all or part of such funds are referred to as the "Contributed Amount(s)"). The maximum Contributed Amount for each Program Activity is as follows:

b. <u>Other Support.</u> If the University and Donor mutually agree, the Donor may also contribute inkind services to the University to help promote the work of the University, the Program, or the University faculty, students, and staff.

6. <u>Grant Process and Administration.</u>

a. <u>The University Grant Request.</u> The University shall submit an annual written request according to the schedule below to the Donor for the Donor's consideration (the "University Grant Request"). If the Donor approves the University Grant Request, the Donor shall make a contribution up to the amount listed in the below schedule to the University, and the University shall accept such Contributed Amount. If the Donor does not approve the University Grant Request, the Donor is under no obligation to contribute any funds to the University.

b. <u>The University Grant Request and Proposed Grant Award Schedule.</u>

c. <u>The Fund.</u> The University shall place all of the Contributed Amount in a segregated and restricted fund on its books and records called the "PEP-CKF Fund" (the "Fund"). The University shall solely use the Fund to support the Program Activities as stated in this Agreement. The University shall make the Fund available for contributions from other donors. If another donor makes a contribution to the Fund, the University shall promptly notify the Donor of the amount donated and, if permitted by the other donor, the name of the other donor.

7. <u>Contributed Amount Used Solely for Charitable Purposes for the Program Activities.</u>

a. <u>Tax Status.</u> According to IRS records, the University is an organization described within the meaning of Internal Revenue Code (the "Code") sections 501(c)(3) and 509(a)(1). The University shall immediately notify the Donor if its tax status changes.

b. <u>Charitable Purpose</u>. The University shall use the Contributed Amount solely for the Program Activities, which is a charitable purpose described in section 170(c)(2)(B) of the Code. The University shall not use the Contributed Amount to influence legislation as described in section 4945(d)(1) of the Code, to influence the outcome of any election, for a political campaign or intervention, to carry on any voter registration drive, or any other purpose that would jeopardize the Donor's tax-exempt status or subject the Donor to penalties under Chapter 42 of the Code.

c. <u>Program Activities.</u> The University shall return to the Donor any Contributed Amount not spent for the Program Activities.

8. <u>General Terms.</u>

a. <u>Term.</u> The term of this Agreement is from the Effective Date to the later of March 1, 2023, or until the University has spent all of the Contributed Amount, unless earlier terminated pursuant to this Agreement.

b. <u>Termination</u>. The Donor has the right to terminate this Agreement if: (i) the University breaches any term of this Agreement; (ii) the Program Activities are not advancing the Program's Mission; or (iii) such action is necessary to comply with any law applicable to the University or the Donor. Such termination is effective upon the expiration of thirty days from the date notice was provided by the Donor to the University. If the Agreement is terminated, the University shall return all unspent Contributed Amounts to the Donor within fifteen days of the Donor's request. The University is not relying on the Donor's proposed funding under this Agreement to incur any obligation or take any action or inaction.

c. <u>Publicity.</u> The Parties shall give each other a reasonable opportunity to review any significant public announcement related to the Agreement. The Parties shall not use each other's logos without the applicable Party's express written consent.

d. <u>Donor Notice.</u> The University shall notify the Donor upon receiving records requests for this Agreement or related information.

e. <u>Entire Agreement.</u> The terms contained in this Agreement supersede all prior oral or written agreements and understandings between the Parties related to the matters contained in this Agreement and constitute the entire agreement between the Parties with respect to the matters contained in this Agreement.

f. <u>Order of Precedence.</u> If there is a conflict between the terms of this Agreement and the terms in the Proposal, this Agreement controls.

g. <u>Amendments.</u> No amendment to this Agreement will be effective unless it is in writing and signed by the Parties.

h. <u>Severability.</u> The terms of this Agreement are severable. If any court of competent jurisdiction construes any term of this Agreement to be illegal, invalid, or unenforceable, the legality, validity, and enforceability of the remaining terms of this Agreement will not be affected.

i. <u>No Waiver</u>. No delay or failure by any Party to enforce any right or claim under this Agreement is a waiver of such right or claim. Any waiver by any Party of any term of this Agreement is not a further or continuing waiver of such term.

j. <u>Third Party Rights.</u> This Agreement does not confer any rights or remedies upon any third party other than the permitted assigns of the Parties.

k. <u>Governing Law: Venue.</u> This Agreement is governed, interpreted, and enforced in accordance with the laws of the Commonwealth of Virginia, without regard to conflict of law provisions. Any action or proceeding filed relating to this Agreement must be commenced and maintained exclusively in the state courts located in Arlington County, Virginia, or the federal courts located in the Eastern District of Virginia. Each of the Parties consent to the exclusive personal jurisdiction of such courts for any such action or proceeding.

1. <u>No Assignment.</u> The University shall not transfer or assign its respective interests in the Agreement or any amount to be contributed pursuant to this Agreement without the express written consent of the Donor.

m. <u>Notice.</u> All notices in connection with this Agreement must be in writing and are effective when delivered personally by hand or one business day after the day sent by overnight courier at the address below, or to another address provided by a Party to the other Parties.

ATTACHMENT A

Johns Hopkins University Proposal to Charles Koch Foundation for Support of the Program on Educational Pluralism

Mission

The mission of the Program on Educational Pluralism (the "Program"), housed at the Institute for Education Policy ("Institute") in the School of Education (the "School"), is to provide intellectual leadership and explore policy alternatives with educational leaders looking to advance a system of diverse, publicly funded, and publicly accountable district, charter, and private schools.

Program Activities

Deputy Director Stipend

The Deputy Director Stipend for Dr. Ashley Berner, who was selected by the University, according to its normal procedures, will allow her to devote a significant amount of her time and resources to work related to the Program.

Institute Director Stipend

The Institute Director Stipend for Dr. David Steiner, who was selected by the University, according to its normal procedures, will allow him to devote a significant amount of her time and resources to work related to the Program.

Administrative Coordinator

The Administrative Coordinator will provide administrative aid to the Program's leadership through scheduling, light research, and project management.

Financial Administrator

The University will allot 20% of the School's existing Financial Administrator's time and resources to work related to the Program. The Financial Administrator will be responsible for assisting the Program's leadership in allocating and administering the Program's budget.

Director of Research

The Director of Research will oversee the methodology of all research projects.

Pluralism Research Analyst

The University will select, according to its normal procedures, an individual for the Research Analyst position. This individual will help facilitate the Program's research and advance the Program's mission.

School-Culture Project Manager

The School Culture Survey is a best-in-class survey that helps charter, private, and district school and network leaders assess the alignment of practice with mission. The survey includes variations that help educate the public with a particular focus on school board members, administrators, teachers, students, and parents. The Project Manager will interpret results and work with Program Leadership to provide actionable feedback to school leaders. The Project Manager will also maintain a database from the survey results for long-term research on the school effect and ability of school culture interventions to drive student success.

Ph.D. Students

The University will select, according to its normal procedures, two Ph.D. students. The Ph.D. students will help facilitate the Program's research and advance the Program's mission.

Additional Pluralism Research

The program will conduct additional pluralism research as it pertains to various projects within the Program and the mission of the Program.

Media Outreach

The Program will continue to place op-eds in prominent media outlets, address influential national membership conferences, and convene high-impact off-the-record gatherings of change agents.

Team Travel Funds

The Program will provide faculty travel funding as it relates to the Program's mission.

PhD Students' Research/Travel Funds

The Program will provide the two Ph.D. students research and travel funding as it relates to the Program's mission.
